Hi Joe,

This not something we have ever been asked before. Obviously we follow standard principles of reducing food waste and avoiding single use plastic wherever possible but we have never calculated carbon impact of a specific menu/event.

Having had a quick Google it appears that 8kg of CO2 is the average of a three course meal in a restaurant, with 70% of this coming from food production so I would imagine we are broadly similar.

In brief:

All flowers are seasonal and have been grown locally

All meat used is from the UK, with the chicken being from Kent

All butter, dairy etc is from the UK

Melon is from Honduras, by sea I would imagine

Prawns are from Ecuador, also by sea

Vegetables from Europe, by road

Passion Fruit from France
